Investment Objective

To provide an optimal growth of investment by investing in minimum 80% on fixed income instruments which includes government and corporate bonds, and by investing in maximum 20% on money markets instruments.

REKSA DANA NIKKO TRON DUA ("Nikko TRON Dua") is an Indonesian open-ended mutual fund as regulated by Capital Market Law No. 8, 1995 and by all relevant BAPEPAM-LK's regulations on the mutual fund.

Open-ended means that investor can subscribe and redeem at any time. Daily valuation is applied to make sure that the investor get a fair net asset value for subscription and redemption.

However, to optimize risk and return, it is the Investment Manager's strategy to have a time planned horizon for 3-5 years, that investors is expected to commit within the time frame.

The fund invest solely in fixed income investments, which are bonds and money market instruments. It limits the amount of risk taken by investors by investing in 3-5 years maturity bonds, whilst keep seizing the opportunity on price movement by a 20% maximum allocation on longer term bonds.

Quality is maintained by putting restriction for investment in bonds that are only the ones with minimum rating of A- (single A minus).

Bond funds typically represent a lower risk in the investment spectrum, and as such should have a place in almost any portfolio, including yours, to provide balance and diversification.
