

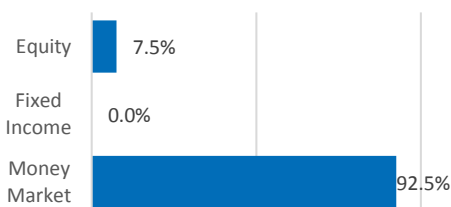

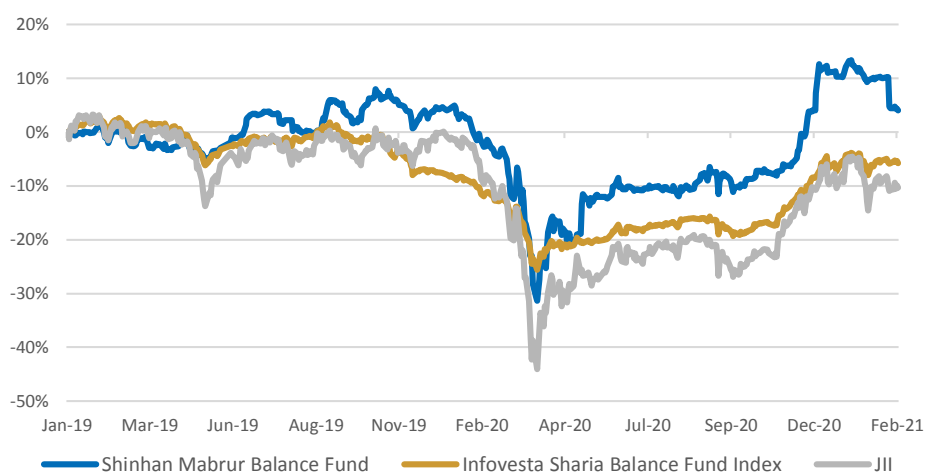

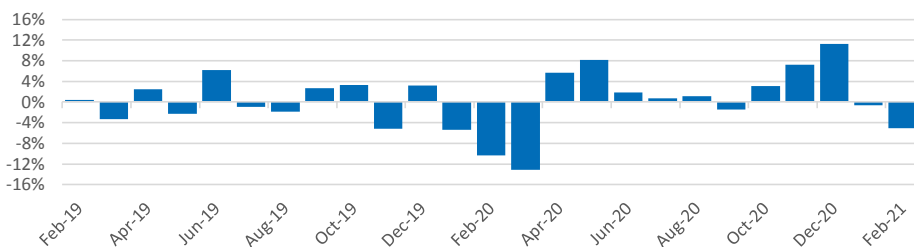
Performance Graph
