The Fund aims to achieve medium to long term capital gains through an actively managed portfolio of equity, fixed income, and money market instruments.

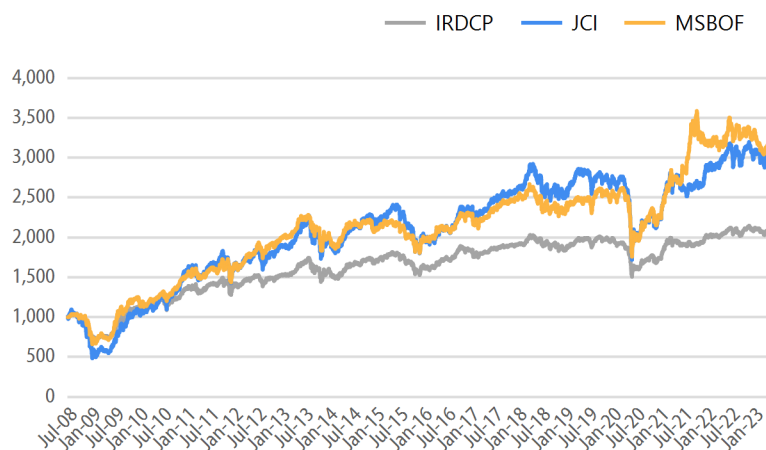
Investment Strategy
