The fund's objective is to achieve optimum long term asset growth through investment in equities. The fund is actively managed.

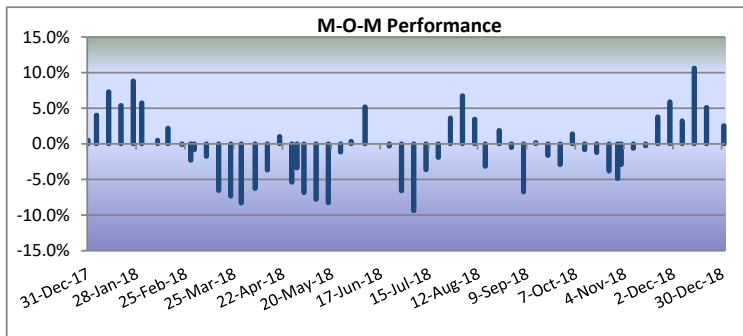
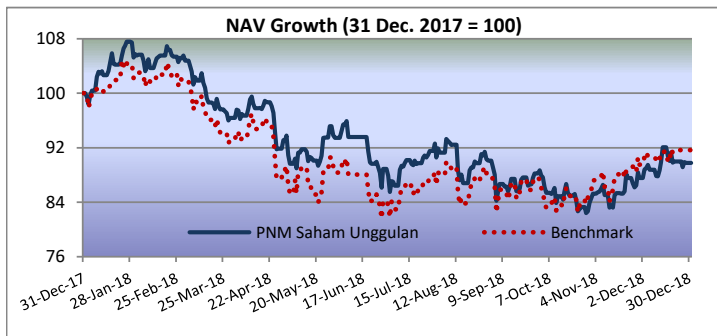
