### Investment Objective

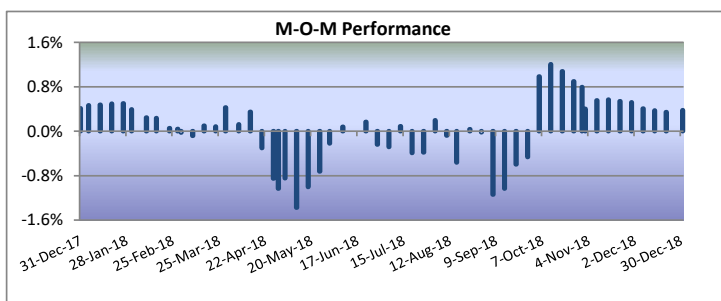
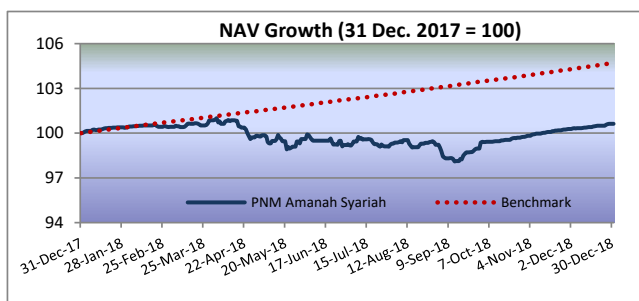
