

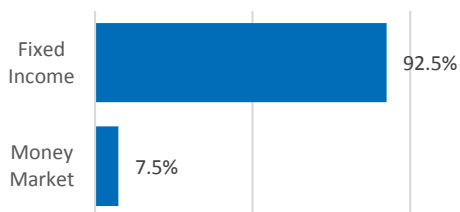

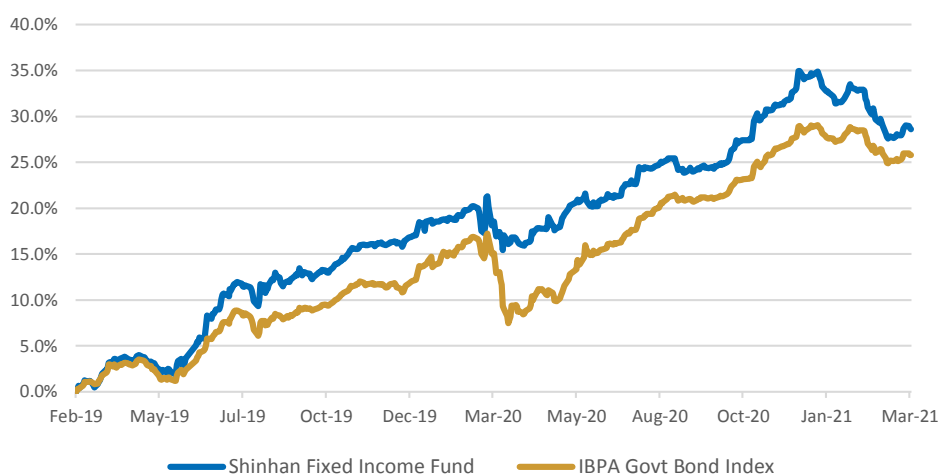

Shinhan Fixed Income Fund aims to provide mid to long term return while maintaining stability through prudent fixed income portfolio management.

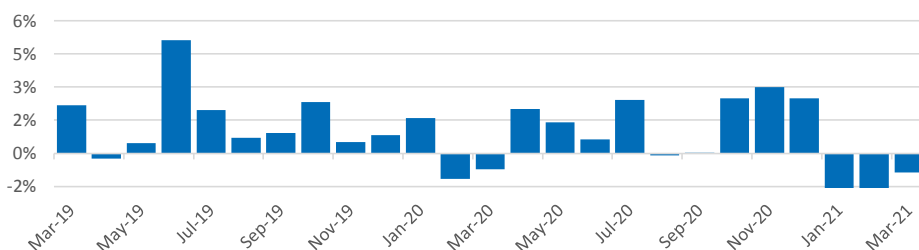
Performance Graph
